Clerk Kelly will be the EVC Administrator and the QVF Coordinator, and Renee Cunningham, Chief Deputy County Clerk will be the backup.

Clerk Kelly advised that the change has been made with the Vendor. The ballot proofing is now correct. Bill Fink, Portage Township Trustee, requested a word be capitalized. Clerk Kelly advised that the School Superintendent and Attorney stated the change was not necessary.

Clerk Kelly stated Elm River Schools requested the word "District" they previously submitted me eliminated from the ballot. The vendor has taken the word District out of the heading. The ballot proofing is now correct.

Clerk Kelly advised that Aaron Janke, Trustee, was missing on the Osceola ballots. The vendor has corrected the error, and it is correct now on the ballot proofing. The Village of South Range

had to move Justin Marier to a partial term-vote for 1. The full term race has a vote for 3. The amending proofing is now correct.
